The Kingdom of Cambodia has received loan/grant from the Asian Development Bank (ADB) and a loan from Asian Infrastructure Investment Bank (AIIB) toward the cost of Greater Mekong Subregion Cross-Border Livestock Health and Value Chains Improvement Project (CLHVCIP), and it intends to apply part of the proceeds of these loans and grants to payments under the Contract for **Supply and Delivery of Office Furniture and Computing Equipment, CAM-MAFF-CLHVCIP-G01A**.
2. The **Ministry of Agriculture, Forestry and Fisheries (MAFF)/General Directorate of Animal Health and Production (GDAHP), Cambodia** now invites sealed bids from eligible and qualified bidders for Supply of Office Furniture (Lot 1) and Computing Equipment (Lot 2) as follows:

3. Bidders may bid for one or more lots, bid evaluation will be carried out lot-wise basis. Procurement will be conducted through National Competitive Bidding Procedures specified in the RGC's Standard Operating Procedures on Procurement for All Externally Financed Projects/Program, under the laws and regulations governing public procurement within the Kingdom of Cambodia, and in accordance with the Financing Agreement and Procurement Regulations of **Asian Development Bank (ADB)**.
4. This invitation is open to all eligible bidders from eligible source countries as described in the Bidding Document.
5. 6. Qualification requirements include:

- ☐ The bidder has satisfactorily completed at least two similar contracts for each lot, for the supply of similar goods in the preceding three years (2021, 2022, and 2023) of not less than:

- ☐ The bidder has completed contracts in the total cumulative amount equal to at least the following in the preceding 2 years (2022 and 2023):

- ☐ The Manufacturer of the offered goods, if a different entity from the Bidder, has experience of at least 3 years in the manufacturing of similar goods.
- ☐ The bidder has availability of liquid assets through either: (i) access to a line of credit or cash in bank account of an amount at least:

Or, (ii) credit terms with vendors specifically for the goods to be supplied under the contract, and valid for at least 6 months after the deadline date for submission of bids specified in ITB Clause 21.

The Royal Government of Cambodia (RGC) and the Asian Development Bank (ADB) will respectively declare a bidder ineligible either indefinitely or for a stated period of time, to be awarded a contract financed by them, if it at any time they determine that the bidder has engaged in corrupt or fraudulent, coercive, collusive or obstructive practices in competing for or in executing a contract.
